JOB PURPOSE

The Degree Mentor will support, mentor and teach students enrolled on the courses by facilitating tasks and proving collective and individual support to maximise student's successful completion of the degree programmes. This will involve overseeing the student's participation in distance learning webinars and manage student's adherence to deadlines on a weekly basis. The successful candidates will also support the recruitment of new students onto the courses to help grow the programme.

ROLES AND RESPONSIBILITIES

- To deliver against agreed contractual KPIs and departmental strategic objectives
- · To attend any Mentor CPD sessions delivered by USW or EFL in the Community
- · To recruit, mentor and teach degree students enrolled on programme at the Trust
- To facilitate tasks and provide collective and individual support to maximise students' successful completion of degree programme
- To work with wider Trust staff to compile student timetable that allows for sufficient classroom time, alongside practical delivery as per their placement requirements
- To be responsible for organising adequate, safe and specific work placement opportunities as part of the student's programme and provide support to students while working on behalf of the Trust
- To organise and attend key recruitment event opportunities both in person and virtually, to meet recruitment targets of a minimum of 8 new learners to the degree each year
- To interview students who have applied for one of the courses and only accept students who meet the entry level requirements and who you feel have the commitment to successfully complete the course
- To manage student's adherence to deadlines and remind students of deadlines on a weekly basis to ensure they are achieved
- To act as the students first point of contact for queries and concerns but direct any
 more serious matters or those you don't feel comfortable responding to, to the USW
 course leader.
- · To monitor students on their work placement and provide feedback where necessary
- To organise the provision of suitable learning resources at the Trust. This involves ensuring the students have regular access to an appropriate private study space
- To actively market the course to potential students using marketing materials provided by USW and EFL in the Community
- To proactively promote the trust to ensure awareness, growth and expansion of its work
- · To ensure compliance with all BFCCT Policies and Procedures across all areas of work
- · To represent the trust in a professional manner and consistent with Core Values
- To undertake training and CPD as necessary and relevant to the post
